

ENMAX Energy Corporation ("ENMAX Energy") \$500 Energy Credit Contest – 2010 Calgary Home and Garden Show (the "Contest")⁺

Official Rules (the "Rules")

To enter the Contest, entrants can go to the ENMAX Energy's EasyMax[®] booth, located at the Calgary Home and Garden Show, to enter to win one of four (4) \$500 EasyMax[®] energy credit prizes from ENMAX Energy. No purchase is necessary.

Eligibility

How to Enter

No purchase or registration is necessary to enter. You can enter by completing an entry form at the EasyMax booth at the Calgary Home and Garden Show.

Dates

Contest opens at 12:00 p.m. on February 25, 2010 and closes at 6:00 p.m. on February 28, 2010 (MST).

Prizes

There are four (4) prizes available to be won. Each prize consists of a five hundred dollar CDN (\$500) EasyMax energy credit (the "Prize"), which will be applied to the EasyMax account of the person whose entry form is drawn who (i) answers a time-limited mathematical skill-testing question correctly, and (ii) complies with the Rules. In the event that a person whose entry form is drawn is not an EasyMax customer, and does not wish to become an EasyMax customer, there are four (4) alternate cash prizes available to be won of two hundred and fifty dollars CDN (\$250) each, which will be awarded provided that the person whose entry form is drawn (i) answers a time-limited mathematical skill-testing question correctly, and (ii) complies with the Rules.
