
ENMAX NO. 34 SUBSTATION

PROPOSED SUBSTATION UPGRADES



PROJECT OVERVIEW

ENMAX Power Corporation (ENMAX) is proposing to replace two existing oil filled power transformers totaling 38.3 MVA with one 50 MVA unit at ENMAX No. 34 Substation located at 3710 – 32 Avenue NW. The current standard for new transformers in the ENMAX system is 50 MVA, and this upgrade is required to ensure the continuous delivery of safe, reliable power.

All work will occur within the present substation perimeter or area. ENMAX will submit an application to the Alberta Utilities Commission in August 2018 and pending approval, will commence work in June 2019 with completion in October 2019.
